This notice of Hollander, LLC (referred to as "Hollander", "we", "us" or "our" in this privacy notice) explains how we collect and process personal data through your use of the CoreConnect website. #### **COLLECTION OF PERSONAL DATA**

We receive information directly from the individual and from our customers as well as from their devices. We supplement the information with data from third parties such as core buying companies. We collect the information to provide the service and to assist our customers with selling recycled core parts. We also use the information to improve our products and services.
